### Cadet

- Child under the age of 18 on 1<sup>st</sup> January
- Any child under the age of 16 must have a parent/grandparent/guardian who is a member of SLYC
- Full use of club facilities shore and water

### Ordinary

- Adult over the age of 18
- Full membership rights, including vote at General Meetings
- Full use of club facilities shore and water
- Sign in guests for bar & social occasions up to 6 times per year per person
- Sign in crew members for races up to 3 times per year per person
- Sub Category Junior A - 18 - 20 on 1<sup>st</sup> January
- Sub Category Junior B - 21 - 24 on 1<sup>st</sup> January
- Sub Category Junior B\* - 21 - 24 on 1<sup>st</sup> January in full time education
- Sub Category Senior over 65 – must have been an SLYC member for a minimum of 5 consecutive years
- Sub category Senior over 75 – must have been an SLYC member for a minimum of 15 consecutive years

### Family

- One or two adult members and any of their children under the age of 18 on 1<sup>st</sup> January
- Same benefits as ordinary member
- Sub Category Senior over 65 – both adults must have been an SLYC member for a minimum of 5 consecutive years
- Sub category Senior over 75 – both adults must have been an SLYC member for a minimum of 15 consecutive years

### House

- Adults 18 years or older
- Use of club shore-based facilities only
